Relative to DepEd Order No. 12 s. of 2015 re: Guidelines on the Early Language, Literacy, and Numeracy Program: Professional Development Component and DepEd Order No. 8 s. 2015 entitled Policy Guidelines on Classroom Assessment, this school through **Project LENS (*Leveraging the Enhancement of Numeracy Skills*)** announces the administration of Mid-Year Assessment in Numeracy for School Year 2022-2023 on April 26, 2023.
2. The main objective of this mid-year assessment in numeracy is to determine the numeracy level and to profile the learners of this school from across grade levels (GRADES 1-6 pupils) for the implementation of immediate and appropriate intervention programs as gleaned on the Project LENS.
3. The dissemination of validated numeracy assessment tools shall be provided through Google Drive. Also, the materials and reproductions of the test questionnaires are chargeable against School MOOE.
4. It is also understood that Math teachers/ advisers are responsible to conduct the Test during their math class and to check and consolidate the results using the official school summary templates.
5. The consolidation and validation of test results and profiling of Non-numerates shall be administered by the School mathematics coordinator and members of Project LENS submitted to the School head and endorsed to the District supervisor. Likewise, the consolidated test results will also serve as the primary foundation for all next initiatives and studies.
