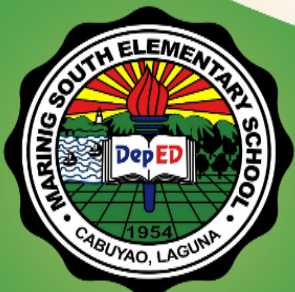
A. DESCRIPTION

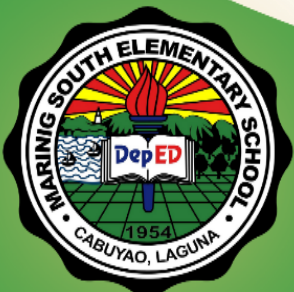
